B. Agreement for Global Treasury Management Services

The Association agrees that each Contracting Officer is authorized to enter into agreements for Global Treasury Management Services with Bank and to designate from time to time who is authorized to use the services and give instructions on behalf of Association with respect to the services. The services are governed by the All About Global Treasury Management Services disclosure, as it may be amended from time to time, which the Association acknowledges receiving or having access to on the Bank's website.
